**AN ORDINANCE AMENDING CHAPTER 110 (A) (1) ENTITLED " LICENSE FEES-
CLASSIFICATION- AMUSEMENT- AUTOMATIC AMUSEMENT DEVICES"; 110.51 (A)
ENTITLED " AUTOMATIC AMUSEMENT DEVICE"; AND, 110.51 (D) ENTITLED "
DEVICES TO BE KEPT IN PLAIN VIEW; GAMBLING DEVICES PROHIBITED" OF THE
LOCKPORT MUNICIPAL CODE .**

ORDINANCE NO. 12-036

AN ORDINANCE AMENDING CHAPTER 110 (A) (1) ENTITLED " LICENSE FEES- CLASSIFICATION- AMUSEMENT- AUTOMATIC AMUSEMENT DEVICES"; 110.51 (A) ENTITLED " AUTOMATIC AMUSEMENT DEVICE"; AND, 110.51 (D) ENTITLED " DEVICES TO BE KEPT IN PLAIN VIEW; GAMBLING DEVICES PROHIBITED" OF THE LOCKPORT MUNICIPAL CODE .

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOCKPORT, WILL COUNTY, ILLINOIS:

SECTION ONE: That Chapter 110 (A) entitled " License Fees- Classification- Amusement- Automatic Devices" is hereby amended by adding said section to read as follows:

§ 110.30 LICENSE FEES.

It shall be unlawful for any person to engage in or operate any business, trade, occupation, or activity named in this section without paying in advance the license fees listed below in an appropriate fee schedule. Such fees, upon collection, shall become part of the general corporate fund.

SECTION TWO: That Chapter 110.51 (A) entitled "Automatic Amusement Devices" is hereby amended to read as follows:

§ 110.51 AUTOMATIC AMUSEMENT DEVICES.

(A) As used in this chapter, the following definition shall apply. **MECHANICAL AMUSEMENT DEVICE.** A machine which, upon insertion of a coin, trade-token, or slug, operates as a game or contest of skill or amusement of any kind or description. This also includes each machine vending recorded music or a period of radio or television entertainment in return for the insertion of a coin, trade-token, or slug; provided this does not include coin-operated radios or television sets in private quarters.

SECTION THREE: That Chapter 110.51 (D) entitled "*Devices to be kept in plain view: Gambling Devices Prohibited*" is hereby amended to read as follows:

(D) *Devices to be kept in plain view: Gambling Unlawful except pursuant to State Law.* All such devices shall at all times be kept and placed in plain view of any person or persons who may frequent or be in any place of business where such devices are kept or used. It shall be unlawful for any license holder to suffer or permit any species of gambling in the premises or any part thereof or any place adjacent thereto under the license holder's control unless authorized under the state law.

SECTION FOUR: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION FIVE: The provisions in Sections of this Ordinance shall be deemed to be separable and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.

SECTION SIX: The City Clerk of the City of Lockport shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.
